Overview

Mike Delaney has represented management in traditional labor relations matters, including collective bargaining negotiations, grievances and arbitrations, and union campaigns and matters before the National Labor Relations Board for more than 39 years.

Mike also represents public and private employers in employment litigation and human resources counseling, including matters involving wage and hour, occupational safety and health, age, sex, race and disability discrimination, and affirmative action before the Equal Employment Opportunity Commission, U.S. Department of Labor, Office of Federal Contract Compliance Programs, the Occupational Safety & Health Administration, and similar state and local agencies. Mike also represents school districts in personnel and school law matters. As a trial lawyer, he has represented employers in courts, before administrative agencies and in arbitration throughout the U.S. He maintains a mediation practice and is a member of the mediation panel for the U.S. district Court for the Western District of Missouri.

He practices with the Spencer Fane Labor and Employment Law group and has served as practice group leader. Mike also served two terms on the firm's executive committee.

Mike received his bachelor of arts degree from the University of Kansas. After service in the U.S. Army, including a tour of duty in Vietnam, he attended the University of Kansas School of Law where he received his law degree. He served as Articles Editor of the *University of Kansas Law Review*. He was named a member of the Honor Society of Phi Kappa Phi and the Order of the Coif, and was the recipient of the C.C. Stewart award as the top student in his graduating class.

Mike is an adjunct faculty member at the KU Law School, where he teaches courses in Labor Law and Collective Bargaining and Dispute Resolution. He has been a frequent author and lecturer on labor relations, employment and school law topics including wage and hour compliance, OSHA and employment discrimination issues and alternative dispute resolution procedures. He has been a contributing editor to *The Developing Labor Law*, published by the ABA Section of Labor & Employment Law. He has been the co-chair of the annual Heartland Labor and Employment Law Program in Kansas City and is a member of the Labor and Employment Law Section and Forum on the Construction Industry of the American Bar Association. He has also been an active member of the American Employment Law Council,

the Education Law Association and the National School Board Association Council of School Attorneys. Mike was 2011 President of the Missouri Council of School Attorneys and served as a member of the Board of Directors of the Associated Builders & Contractors, Inc., Heart of America Chapter.

Mike has been elected a Fellow of the College of Labor and Employment Lawyers and a Fellow of the Litigation Counsel of America. He is a member of the Wage & Hour Defense Institute.
