

#### **Overview**

Rodney is the former chairman and vice chairman of the Bank Counsel Section of the Missouri Bankers Association and remains a member of its Advisory Board. Having this leadership experience and knowledge of the industry, he regularly speaks on current legal issues and trends that impact financial institutions.

Apart from financial services, Rodney handles commercial and real estate litigation, including appeals, in both state and federal courts. Having handled litigation involving contracts, construction, real estate and trust disputes, Rodney's experience in court is wide-ranging and helps him better assist clients in the early stages of transactions to avoid litigation down the road or to better protect the client's interest should disputes arise.
